began her tenure at Penn Medicine in 2013 as a medical resident and has since risen to become the Medical Director of Penn Medicine Lancaster General Hospital in the department of Radiation Oncology. Dr. Boimel was a driving force behind the successful launch of the second proton therapy center with Penn Medicine—and only the second in Pennsylvania—spearheading the development of new clinical protocols, optimizing patient care workflows, and providing strategic guidance in facility design. Her leadership extended beyond clinical operations, playing a critical role in community outreach, marketing and education, significantly increasing awareness and accessibility of proton therapy.



#### Sebastian Haines

Sebastian Haines joined the Department of Radiation Oncology at Penn Medicine as its Senior Director of Operations in 2021 and was promoted into his current role as Associate Chief Operating Officer in 2024. He is accountable

for clinical operations for the department and serves as the administrative dyad to the Vice Chair of Clinical Operations and the Vice Chair of Network Operations. Sebastian's 15 year career has spanned several states and included roles with academic and for-profit healthcare systems. He has been with Penn Medicine for over 10 years and prior to joining the department served as the Director of Operations for the Primary Care Service Line where he led the development and implementation of practice based care management and mental health programs and was accountable for achieving success in value based payment programs covering over 500,000 patients. therapies and radiation for lymphomas. He was the principal investigator for a multi-site trial using proton therapy for re-irradiation and has organized a multi-center effort around the use of radiation bridging for CAR T-cell therapy. He served in leadership positions on the Hematologic Track Scientific Committee for the Annual meeting of the American Society for Radiation Oncology (ASTRO). He has been the Chair of the Education Committee and a member of the Steering Committee of the International Lymphoma Radiation Oncology Group (ILROG). He is a member of NRG Lymphoma Working Group and represents NRG on the National Cancer Institute Leukemia Steering Committee. At Penn Medicine Radiation Oncology, he is the Vice Chair for Strategic Clinical Research and the Chief of the Hematologic Malignancies Service. He serves as the co-Chair of the Abramson Cancer Center's Scientific Protocol Review Committee. He has been a chair of one of the Institutional Review Boards at the University of Pennsylvania that focused on cellular therapies and high risk cancer trials for several years. His latest challenge is to bring proton therapy to the West Philadelphia community as Chief of Radiation Oncology and Proton Therapy at Penn Presbyterian Medical Center.
